ARDMS Introduces New Registered Musculoskeletal Sonographer™ (RMSKS™) Credential

ROCKVILLE, MD (June 2, 2015) – In January of 2015, the American Registry for Diagnostic Medical Sonography® (ARDMS®) committed to review the **RMSK®** certification and determine how ARDMS can respond to the growing and diverse field of MSK imaging. ARDMS announced today the launch of the Registered Musculoskeletal Sonographer™ (**RMSKS™**) credential. A separate musculoskeletal-sonographer examination written by and for sonographers, the **RMSKS™** credential is part of a larger initiative to expand and customize the MSK ultrasound assessments within the medical community.

The administration of the first RMSKS™ credentialing examination will be in the fall of 2015.

"Musculoskeletal imaging is a game-changer for the medical profession--we knew that for certain when we first introduced the certification," said Thomas D. Shipp, MD, RDMS, Chair of the ARDMS Board of Directors. "As interest increased in MSK certifications from many different types of users, we saw a greater need for tailored assessments like the **RMSKS™**. The reach of ultrasound imaging is further expanding into new medical specialties and so is ARDMS."

Over the last five months, ARDMS collected over 900 responses from the **RMSKS™** Job Task Analysis (JTA) Survey. The findings from this research coupled with meetings and feedback with related health and medical associations prompted the development of the dedicated sonographer MSK certification. As the organization continues to research and evaluate MSK imaging, there may be a need for specialized exams for advanced care providers such as nurse practitioners, physician assistants, physical therapists and others with an expanded scope of MSK imaging.

"Because we value our Registrants' perspective, we asked the ARDMS community to contribute to the JTA survey--and they delivered," continued Shipp. "As the conversation continues, it will drive and shape the future of our certification programs."
