## Overall Position Purpose

This position exists to serve as an architect in continuing the development of Inteleos' Business Intelligence (BI) program and act as a guide to the organization in how to best exploit our use of data. This position will work directly with internal stakeholders to understand the business needs and the Technology team to develop, design, analyze, identify trends, and deliver data-driven analytical solutions.

## Core Responsibilities

- **Data Harvesting**
  - Work with business users to uncover data sources and find new ways of using discovered data.
- **Data Analysis**
  - Lead the design and development of the Inteleos BI data model;
  - Ensure data integrity and cleansing with the goal to build trust in data; and
  - Work with Technology team to architect the data pipeline from source data systems to analysis systems.
- **Data Education**
  - Provide expertise and guidance to Inteleos staff in the use of the BI toolset, which could include Tableau, spreadsheets, dashboards, and a data warehouse;
  - Conduct software demonstrations/presentations/trainings on a variety of topics within the BI space; and
  - Increase awareness of data literacy concepts; increase staff confidence in use of tools and understanding of concepts to help them make better decisions.
- **Data Visualization**
  - Guide the organization in using the right/best visualizations for each given case;
  - Guide the organization in selecting the most valuable KPIs and PIs as the business evolves; and
  - Apply and use best practices in data visualization as tools and techniques evolve.
- **Data Evolution**
  - Move the organization towards advanced analytics solutions such as data mining and predictive modeling to improve understanding of our customers and business, discovery of new business opportunities, and ultimately make better business decisions; and
  - Build a “center of excellence” in BI through relationships between vendors, developers, and business users.
- **Data Ethics**
  - Monitor data models and use of data for alignment with Inteleos' cultural attributes; and
  - Work with Director of Risk Management and Director of Compliance and Quality Assurance in the development and evolution of data use guidelines and policies to comply with existing and developing data privacy regulations and other compliance requirements.

- Bachelor's degree, Certification or equivalent in Business, data analytics, quantitative analysis, or related field.
- Six years of experience in data wrangling, data analysis, developing analytics, and reports.
- Knowledge in data mining, machine learning and data architecture.
- One or more years leading organizational BI initiatives.

- Proven ability to work in a team environment.
